IGI Global CC Ebook

Seventeen CC schools have purchased at least one IGI ebook to share with the rest of the group, which now jointly owns 43 shared titles.

FEATURED - Wiley UBCM



Wiley calls its evidence-based ebook deal "UBCM", which stands for Usage Based Collection Management. Our group deal runs July 1 to June 30. Each of the 20 participating institutions has access to all of Wiley's 23,000+ ebooks for one year and all the money that we pay is put into a shared pool. At the end of the year, the group uses that money to buy more than 1000 of the titles that were most heavily and widely used. This deal includes the frontlist; new titles are added on an ongoing basis as they are published.

The UNC System ran a 3 year pilot shared UBCM deal and found that schools of all sizes enjoyed a very low cost-per-use and cost-per-purchase. And most schools saw little or no increase in their net Wiley book expenditures.

Participants in the CC Wiley ejournal deal get an extra discount for UBCM, and UBCM subscribers get an extra discount on the journals.



CC NEWS AND UPDATES

Meet Carolina Consortium Advisory Group member Christee Pascale:



Christee is the Head of Acquisitions at the University of South Carolina's flagship campus. She is responsible for managing the University Libraries general collections budget including the negotiation, renewal, licensing, budget forecasting, and budget management for resources in support of teaching and research on the flagship campus, as well as the two year system campuses.

Leading a remarkable team of eight they handle the acquisition, receipt, copy cataloging, payment, management, renewal, licensing, and access to resources in all formats and languages for Thomas Cooper Library, Hollings Special Collections, South Caroliniana, and the School of Music Library. Notably, this team provides sole troubleshooting and access support for the Libraries \$8 million dollar electronic collection.

Christee is also an avid paper crafter, creating handmade greeting cards. She is busy planning the 2022 Holiday card assortment and

Carolina Consortium Meetings Summary:

During the business meeting, the membership endorsed the current CC operating guidelines and structure, and approved the CC Advisory Group's four strategic directions for 2022:

- 1. Begin discussion of succession planning.
- 2. Limit number of new deals that we launch.
- 3. Evaluate the success of CC R&P deals.
- 4. Prioritize OA vs. savings.

Tim reviewed the CC's newest deals and some deals of particular interest, and then delivered two presentations, "COVID Impact on Consortium E-Usage; a Multi-year Analysis" and "Consortium Futures; Sustainable Paths".

Christee and Carol led the Advisory Group's town hall discussion of potential CC strategies, opportunities, and challenges over the next few years.

The parts of the in-person meeting listed above were repeated for the online meeting, and that recording is available in the Box account until mid-July.

The in-person meeting also included brief presentations from two dozen vendors, a vendor hall, lunch, and presentations from CC members Joseph Thomas (ECU), Sarah Falls (School of the Arts), Rick Moul (PASCAL), and Amy Trepal (PASCAL).
